## Robert J. Garrity, Jr.

Bob Garrity – FBI Agent (retired). Attended University of Maryland, Baltimore County, and University of Baltimore School of Law, and the masters University of Southern California.

### Stroke

I was born on September 17, 1952, in Baltimore, Maryland. I am currently 67 years old. I have been an Episcopal all my life.

On October 29, 2007, when I was 55 years, I was a victim of a massive stroke, with total right side paralysis. I was in the shower first, but then felt dizzy, and fell. I fell at 8:00 am and was not rescued until 4:00 pm. I was in Denver, Colorado, and had been for two months, and my wife, was in Fairfax, Virginia trying to sell our home. I was a rehabilitation patient at Craig Hospital, located in Englewood, CO from the time of my stroke until I was released on February 29, 2008, when I then moved back to Texas. I've been recovering from the stroke for last 12 years.

I currently participate in speech therapy at Texas Woman's University (Stroke Center) in Dallas, and University of Texas (Autism Center) at Dallas. I have regained the use of my right leg, which has allowed me to be independent and to drive. I also have attended four six-weeks sessions at the University of Michigan, in their Aphasia Program, where I had intensive one-on-one speech therapy.

### Federal Bureau of Investigation

In August 1976, I became a Special Agent with the FBI, where I served for 32 years. I moved 11 times during my tenure. I served in the Savannah and Statesboro, Georgia Offices; the New York Office on two occasions; the FBI Headquarters on four occasions; Dallas, Texas Office; Jackson, Mississippi Office; and the Denver, Colorado Office. I was the Special Agent in Charge in two divisions, Jackson and Denver.

### Boy Scouts of America

In September 1960, I join the Cub Scouts, and three years later, I joined the Boy Scouts in the Baltimore Area Council. I have been a member ever since – all 59 years. My passion for Scouting goes back to when I was a young boy. I have been involved with the Baltimore Area Council, Coastal Empire Council, Bucks County Council, Watchung Area Council, Longhorn Council, National Capital Area Council, Andrew Jackson Council, and Denver Area Council. Today I serve as Unit Commissioner for four Packs, five Troops, one Crew, and Service Team for five Law Enforcement Explorers.

Linda Seeber is a "Cradle Episcopalian" and has been a member of St. Martin-in-the-Fields for over 20 years.
